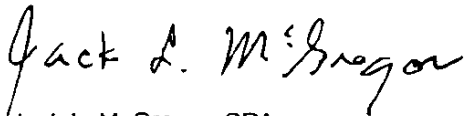
My records indicate the corporation registration report and a \$150.00 check were mailed on April 27, 2006.
