ARTICLE I - NAME

The name of this corporation, formed under the provisions of Section 621, Florida Statutes, is DAVID A. BUCHSBAUM, P.A.

ARTICLE II - PRINCIPAL OFFICE

The aggregate number of shares that this corporation shall have authority to issue is One Thousand (1000) shares of common stock, all of which are to have a par value of One Dollar (\$1.00).
