ARTICLE I - NAME

The name of this corporation shall be ~~B & T Inc.~~ Bracy's First Class Delivery Inc.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III - CAPITAL STOCK


ARTICLE XI


