## ARTICLES OF INCORPORATION OF CENTRAL FLORIDA PROFESSIONAL DEVELOPMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, do hereby adopt the following Articles of Incorporation:

<u>Article 1. Name</u>. The name of the Corporation is: CENTRAL FLORIDA PROFESSIONAL DEVELOPMENT, INC. The principal office of the Corporation is 1004 Featherstone Circle, Ocoee, FL 34761.

Article 2. Duration. The duration of the Corporation is perpetual.
