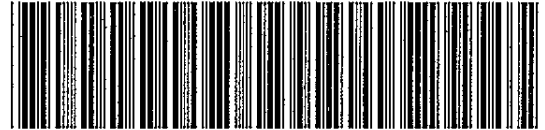



The undersigned incorporator, for the purpose of forming a professional association under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

**Article One: Name**

The name of this Professional Association ("Professional Association") shall be "Tabor & Lavargna, P.A."



**Article Seven: General Provisions**

A. This provisions shall be in addition to any other rights to which those indemnified may be entitled under any By-laws, agreements, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and is to continue to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors and administrators of such person.
