

The undersigned incorporators make, subscribe, acknowledge, and file with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Corporation is **Hillwig Enterprises, Inc.** with a principal office of: 5437 Vineland Road Orlando, Fl 32811, and a mailing address of 5437 Vineland Road Orlando, Fl 32811.

ARTICLE II: TERMS OF EXISTENCE

This Corporation shall commence as of December 21, 2005 and shall have perpetual existence.

ARTICLE III: NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV: CAPITAL STRUCTURE
