The undersigned, acting as Incorporator of a Florida corporation ("Corporation"), executes and acknowledges these Articles of Incorporation pursuant to the Business Corporation Act for the purpose of forming a corporation under the laws of the State of Florida.

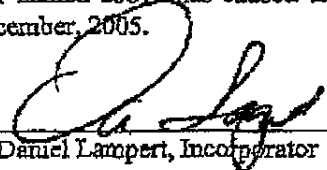
