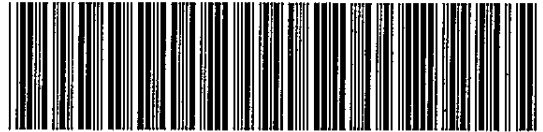

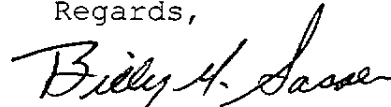

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation to be effective as of January 1, 2006.

**ARTICLE I. NAME.**

The name of the corporation shall be Ruth McClain Sasser Memorial Investment Club, Inc.

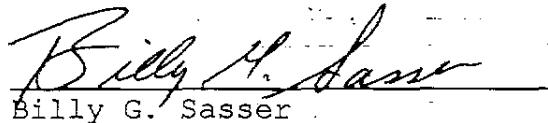
