

ARTICLES OF INCORPORATION EMPIRE REMODELING COMPANY

ARTICLE I. Name

The name of this corporation is EMPIRE REMODELING COMPANY. 5The principal business/mailing address is: 4365 Fay Blvd., Cocoa, Florida 32927.

ARTICLE II. Duration

The corporation shall have perpetual existence.

ARTICLE III. Effective Date

The effective date of the corporation is January 1, 2006.
