ARTICLES OF INCORPORATION
OF
KENDALL J. PHILLIPS, P.A.

In compliance with chapters 607 and 621 F.S. 2005.

ARTICLE I
NAME

The name of the corporation shall be Kendall J. Phillips, P.A.
