#### ARTICLE I - Name

The name of this corporation is Michael Albert Creative Coatings, INC.

#### ARTICLE II - Purpose

- 1. This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, conducting the specific business of the operation of driveway, pool decks, walkway coatings, etc. and all other related business matters.

- 8. To carry on any or all of its operation and businesses and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.
- 9.
