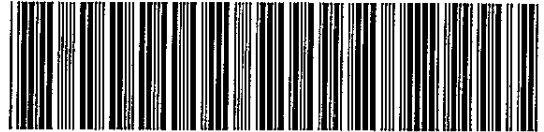



Articles of Incorporation

A Florida for-profit corporation

THE UNDERSIGNED, acting as incorporator(s) of a Florida for-profit corporation under chapter 607, Florida Statutes (the "Act"), hereby adopt(s) these Articles of Incorporation of Lewis Vaughn Masonry, Inc., ("the Corporation" or "this Corporation" hereafter), and certifies the following information:

I. ARTICLE 1 - NAME. The legal name of this Corporation is:

Lewis Vaughn Masonry, Inc.

II. ARTICLE 2 - PURPOSE & POWERS. The Corporation shall be organized for the purpose of conducting any lawful business and shall, consistent with the Act and Corporate Bylaws, have the same powers as an individual to do all things necessary or convenient to carry out the Corporation's purpose, business and affairs.

III. ARTICLE 3 - DURATION. Upon effectiveness, this Corporation's term shall be perpetual unless dissolved sooner upon the happening of any mandatory dissolution event as according to the Act or Bylaws of the Corporation.

IV. ARTICLE 4 - ADDRESS. The business of the Corporation shall be principally conducted at, and all Corporation mail/correspondence shall be directed to:

V. ARTICLE 5 - STOCK. The Corporation shall be authorized to issue one hundred (100) shares of common stock, all of one class, with a par value of \$1.00 per share. At the request of a shareholder, the President and Secretary shall authenticate the number of shares held by

certificate which shall bear a legend in prominent type setting forth those items required by s. 607.0625, Fla. Stat., and additionally advising potential transferee/shareholders conspicuously on its face that the security is a "limited security" within the meaning of the Securities Act of '33, and that the interest represented thereby is subject to stock purchase, control and voting agreement and other requirements and restrictions related to transfer.

- VI. ARTICLE 6 - BOARD OF DIRECTORS.** The corporate powers of this Corporation shall be vested in a Board of Directors (the "Board"). Until such time as an election may be held in accordance with the Act and the Bylaws, the initial, sole member and Chair of the Board shall be:

Director and Chair: **Lewis Vaughn**

Consistent with the Act and these Articles, the qualifications and terms of the Board, manner of selection, and the time, place and manner of calling meetings, giving notice of and conducting the meetings, and the number of Directors which shall constitute a quorum at meetings of the Board, shall be prescribed by the Bylaws.

- VII. ARTICLE 7 - OFFICERS.** This Corporation shall have a President and a Secretary-Treasurer who may be the same person and who shall be appointed by and serve at the pleasure of the Board, and who shall manage the conduct and day-to-day affairs of the Corporation. This Corporation may have such inferior officers as the Board may in its discretion determine. The duties, qualifications, manner and time of elections and terms of office of all officers of this Corporation shall be as prescribed by the Bylaws of the Corporation.

Until such time as these Articles be modified by amendment or updated through the filing of an annual uniform business report with the Florida Secretary of State, the principal officers shall be as follows:

- VIII. ARTICLE 8 - BYLAWS.** The Board shall adopt (and may periodically amend) a set of Bylaws concurrent with the execution of these Articles, which Bylaws shall control the ownership of, and regulate the conduct of, this Corporation, to the extent not inconsistent with the Act and these Articles.

- IX. ARTICLE 9 - INCORPORATORS.** The names and addresses of the incorporator to these Articles is as follows:




