Acticle VII: Shareholders shall be extitled as a matter of right to a preemptive right, for a period of thirty days, to subscribe for, purchase or receive any shares of the componstion which it may issue or sell, whether out of the number of shares authorized by these Articles of incorporation or by anasoment thereof, ar out of the chares of the corporation acquired by it after the incance thereof, any shareholder shall be suittled as a caster of right to purchase or subscribe for or receive any bonds, debentures, or other obligations which the corporation may issue or sell that shall be convertible into or exchangeable for a share, or to which shall be attached or shell appearain to any wattent or warrants or other instrument or instruments that shall confer upon the holder provener of such abligation the right to subscribe for or pumbes from the corporation any theres of any class or classes; and after the application of said thirty days, any and all of such abuse, rights, bonds, debentures are other obligations which for corporation may have launch, misraed, transferred, or granted by the Board of Directors, at the case casy be, to each persuas, firms, corporations, and secondarions, and for such lawful consideration, and on such terms, as the Board of Directors in its discretion may determine.

Article VIII: The corporation is organized to engage in any or all lawful business for which corporations may be incorporated under the provisions of the Florida Statutos.

Article IX: The period of diseation of the commention is perpetual.

Article X: The corporation shall, to the fullest extent legally permissible upder the provisions of the Florida Business Corporation Art, as the same may be emceded and supplemented, indentify and hold becomes my and all persons whom it shall have power to indentify under said provisions from and against any and all inbilities (including expenses) imposed upon or reasonably institued by him in connection with any action, sait or other proceeding in which he may be involved or with which he may be threatened, or other metters referred to inter covered by said provisions both as to action in his official capabity and as to action in any other capacity which indiving such office, and said continue as to a person who has caused to be a director or officer of the corporation. Such indemnification provided shall not be described any interruption to which those indomnified may be entitled under any Bylaw, Agreement or Rasolution adopted by the abscabolders untitled to vote thereon after notice.
