

The name of this Corporation is: Luxury Auto Detailing and Pressure Cleaning, Inc.

Effective Date: 1-1-2006

ARTICLE II

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.
