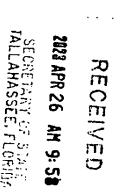

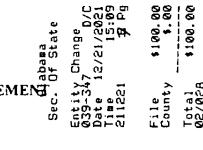

ARTICLES OF AMENDMENT AND RESTATEMENT OF ARTICLES OF INCORPORATION OF CDG ENGINEERS & ASSOCIATES, INC.

These Articles of Amendment and Restatement are filed in accordance with Code of Alabama. 1975, sections 10A-2A-1.20, 10A-2A-10.03, 10A-2-10.06 and 10A-2-10.07.

- 1. <u>Name of Corporation</u>. The present name of the Corporation is CDG Engineers & Associates, Inc. The Corporation's name shall change to CDG, Inc. as of the effective date of the filing of the attached Amended and Restated Articles of Incorporation.
- 2. <u>Date on Which Articles of Incorporation Filed</u>. The Articles of Incorporation of the Corporation were filed on October 20, 1975, with the Judge of Probate of Covington County, Alabama and recorded in Book 28, beginning at Page 94.
- 3. <u>Prior Amendments</u>. The Corporation has heretofore filed Articles of Amendment to its Articles of Incorporation with the Judge of Probate of Covington County, Alabama on: April 2, 1986; February 5, 1996; November 18, 1997; April 13, 1998; August 24, 1998; and April 20, 2005.
- 4. <u>Alabama Entity ID Number</u>. The Corporation's Alabama Entity ID Number is 039-347.
- 5. <u>Date of Adoption; Effective Date of Amendment.</u> The Amended and Restated Articles of Incorporation attached hereto were adopted by the board of directors of the Corporation by unanimous written consent in lieu of a special meeting on August 25, 2021, pursuant to the provisions of <u>Code of Alabama 1975</u>, section 10A-2A-10.05. The effective date of the Amended and Restated Articles of Incorporation shall be January 1, 2022.
- 6. <u>Certificate Regarding No Requirement for Shareholder Approval.</u>
 Shareholder action was not required to approve the Amended and Restated Articles of Incorporation.
- 7. <u>Text of Amended and Restated Articles of Incorporation</u>. The attached Amended and Restated Articles of Incorporation supersede the original Articles of Incorporation and all amendments thereto.

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF CDG, INC.

ARTICLE I. NAME

The name of the corporation is CDG, Inc. (the "Corporation"). A copy of the Name Reservation Certificate from the Office is the Alabama Secretary of State is attached.

ARTICLE II. AUTHORIZED SHARES

The total number shares of the authorized stock of the Corporation is 1,000,000 shares of common stock having no par value. All of the authorized stock is common stock and none is preferred stock or stock of a different class. The Board of Directors may authorize the issuance of some or all of the shares of stock of the Corporation without certificates. This authorization will not affect shares of stock already represented by certificates unless they are surrendered to the Corporation. Within a reasonable time after the issuance or transfer of shares of stock without certificates, the corporation shall comply with the notice requirements of Code of Alabama 1975, section 10A-1-3.45.

ARTICLE III. REGISTERED OFFICE AND AGENT

The street address of the registered office of the Corporation in Alabama is 1829 East Three Notch Street, Andalusia, Alabama 36421. The name of the registered agent of the Corporation at that office is Marcus K. Pugh.

ARTICLE IV. PURPOSE

Section 4.01. <u>Purpose</u>. The purpose for which the Corporation is organized is to engage in the profession of civil engineering and all related services, and in the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Corporation Law, as amended from time to time (the "<u>Law</u>").

Section 4.02. Pursuit of Purposes and Exercise of Powers in Other Jurisdictions. The Corporation may pursue its purposes and exercise its powers in any state, territory, district or possession of the United States, or in any foreign country, to the extent that these purposes and powers are not forbidden by the law of that state, territory, district or possession of the United States, or by the law of that country. The Corporation, if it so elects, may limit the purposes that it proposes to carry out or the powers it proposes to exercise in any application to do business in any state, territory, district or possession of the United States or in any foreign country.

ARTICLE V. CERTAIN POWERS AND RIGHTS

Section 5.01. <u>Indemnification</u>. The Corporation, to the fullest extent permitted by the provisions of the Law, may indemnify any and all persons whom it shall have power to indemnify under the Law from and against any and all of the expenses, liabilities, or other matters referred to in or covered by the Law. The indemnification rights provided for in this Section are not exclusive of any other rights to which such persons may be entitled under any bylaw, agreement, vote of shareholders or disinterested directors, or otherwise.

Section 5.02. Exculpation. A director of the Corporation shall not be liable to the Corporation or its shareholders for money damages for any action taken, or failure to take action, as a director, except for (a) the amount of a financial benefit received by such director to which such director is not entitled; (b) an intentional infliction of harm by such director on the Corporation or its shareholders; (c) an intentional violation by such director of criminal law; or (e) a breach of such director's duty of loyalty to the Corporation or its shareholders. If the Law, or any successor statute thereto, is amended to authorize the further elimination or limitation of the liability of a director of a corporation, the liability of a director of the Corporation, in addition to the limitations on liability provided in this Section, shall be limited to the fullest extent permitted by the Law, or any successor statute thereto. Any repeal or modification of this Section by the shareholders of the Corporation shall be prospective only and shall not adversely affect any limitation of the liability of a director of the Corporation existing at the time of such repeal or modification.
