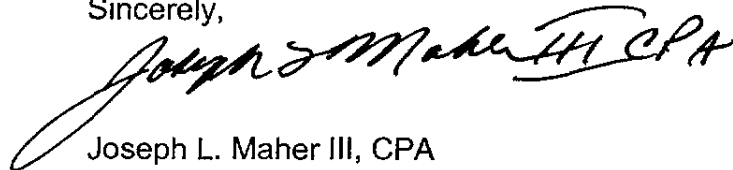

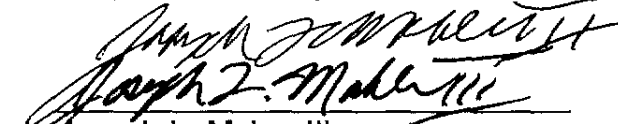
ARTICLE X - IDEMNIFICATION

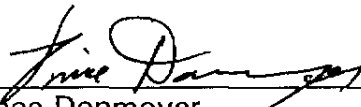
