

STEVEN ALAN ARNOLD, P.A. **(A Professional Association)**

In order to form a professional association under the provisions of chapter 621 of laws of the State of Florida for a formation of a professional association, I, the undersigned, hereby create a professional association for the purpose herein mentioned.

ARTICLE I **NAME**


