The undersigned subscribers to these Articles of Incorporation, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

Article I. NAME of CALE PLOCAD

The name of the corporation is: TCR Enterprises, Inc.

Article II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to:

- 1. To engage in every aspect and phase of the business of performing Welding Services.
- 2. - 5. To purchase the corporate assets of any other corporation and engage in the same or other character of business.

- 6.
