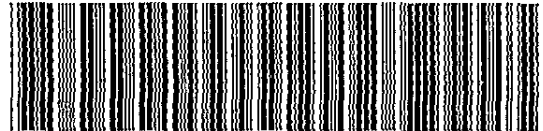

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **WISDOM LIMOUSINE SERVICE, INC** and its principal place of business shall be located at 1761 NW 46TH Avenue, Apt. D-205, Lauderhill, Florida 33313.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
