ARTICLE I. NAME

The name of this corporation shall be Patricia Sylvester, P.A..

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall begin on January 2, 2006 and not earlier, which shall be the time of filing of these Articles of Incorporation by the Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of conducting any and all lawful business activities permitted under the laws of the State of Florida and the United States of America. Under the provisions of section 621.06, this Professional Service Corporation will be dealing with Real Estate Sales.


