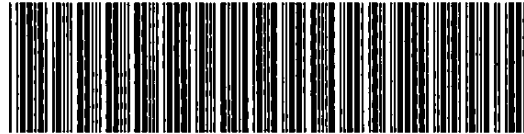




FOURTH: Joseph Fernandes is the sole officer, director and shareholder of the corporation.

FIFTH : The amendment was adopted by the Board of Directors on the 7th day of August, 2006.






