

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF WORTHING PLACE ASSOCIATES, INC.

FILED 06 JAN -9 PM 4: 22

A Florida Corporation

The Articles of Incorporation for Worthing Place Associates, Inc. (the "Corporation") originally filed on January 3, 2006, effective December 29, 2005, with the Florida Department of State and assigned document number P06000000682. The sole Incorporator of the Corporation desires to amend and restate the Articles of Incorporation of the Corporation to read in their entirety as follows:

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF WORTHING PLACE ASSOCIATES, INC. (Filed in accordance with 608.411, F.S.)

ARTICLE I

NAME

The name of the corporation is Worthing Place Associates, Inc. (the "Corporation").

<u>ARTICLE II</u>

MAILING AND STREET ADDRESS

The mailing and street address of the principal office of the Corporation is 900 E. Atlantic Avenue, Suite 13, Delray Beach, Florida 33483.

ARTICLE III

REGISTERED AGENT AND OFFICE

The name and street address of the Corporation's initial registered agent in Florida is Jonathan J. Lichtman, P.A., 120 East Palmetto Park Road, Suite 100, Boca Raton, Florida 33432.

ARTICLE IV

DURATION

The period of duration for the Corporation is perpetual, beginning on the date these Amended and Restated Articles of Incorporation are filed by the Florida Department of State unless earlier terminated by the unanimous written agreement of all Shareholders.

ARTICLE V

CAPITAL STOCK

The Corporation is authorized to issue 10,000 shares of \$.01 par value Common Stock.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

The Corporation shall initially have one (1) Director to hold office until the first Annual Meeting of Shareholders and his successor shall have been duly elected and qualified, or until his earlier resignation, removal from office or death. The name and address of the Sole Director of the Corporation is William E. Morris, 900 East Atlantic Avenue, Suite 13, Delray Beach, FL 33483.

ARTICLE VII

ADOPTION BY INCORPORATOR

These Amended and Restated Articles of Incorporation of the Corporation were adopted by the sole Incorporator prior to the issuance of stock.
