**ARTICLE IV. CAPITOL STOCK**

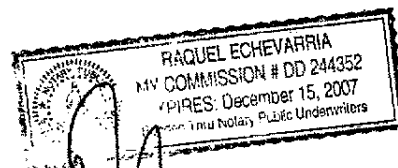

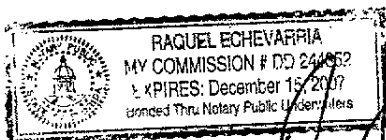
## ARTICLE IX. AMENDMENT
