ARTICLE I -Name

The name of this corporation is A-1 Transportation Services, Inc.

ARTICLE II - Nature of Business

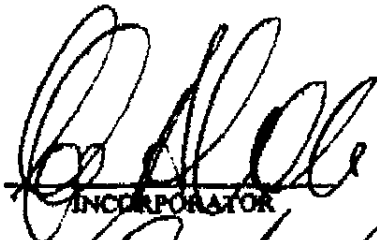
