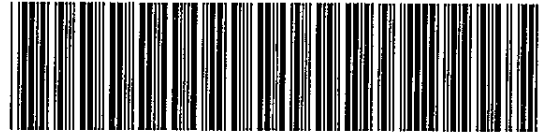

OF

The undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation shall be JOEDEE, INC. The address of the corporation is 1156 S. US#1, Vero Beach FL 32962.

**ARTICLE II  
PURPOSE OF BUSINESS**

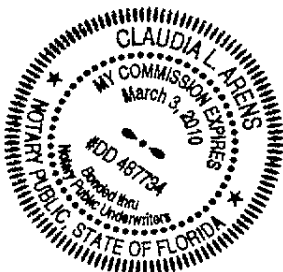
