

ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLES I NAME

The name of this corporation shall be:

ARTICLE IL NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Floridz.
