

OF

RELIABLE BREAD DELIVERY, INC.

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **RELIABLE BREAD DELIVERY, INC.**

The period of its duration is perpetual.


