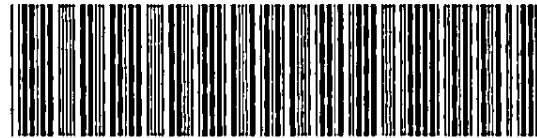


Article I is hereby amended and restated in its entirety to state:
