ARTICLES OF INCORPORATION

OF

INDUSTRIAL WAREHOUSE VENTURES, INC.

EFFECTIVE DATE

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **INDUSTRIAL WAREHOUSE VENTURES, INC.**

The period of its duration is perpetual.
