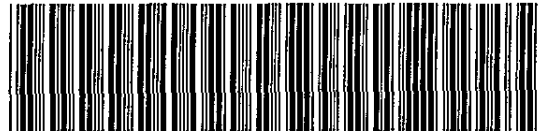

Article 1**

1.1 The name and principal office of this corporation is:

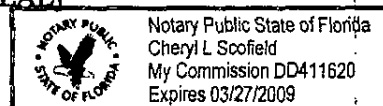

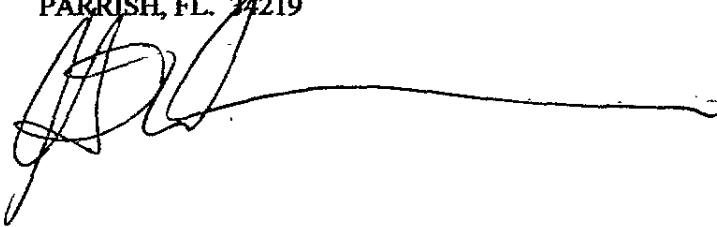
