ARTICLES OF INCORPORATION OF J

# JR Shutters, Corp.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### ARTICLE I-NAME

The name of this corporation is JR Shutters, Corp. (Hereinafter, "Corporation").

#### ARTICLE II - DURATION / TERM OF EXISTENCE

#### ARTICLE VILAMENDMENT

These articles of incorporation may be amended in the manner provided by law.
