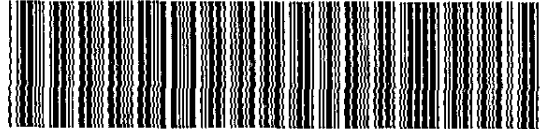

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE
NAME

The name and principal address of the Corporation is: **GREEN JUNGLE LANDSCAPING, INC.**, whose address is 3811 North 43 Avenue, Hollywood, FL 33021.

ARTICLE TWO
DURATION

The term of existence of the Corporation is perpetual.

ARTICLE THREE
PURPOSE

The Corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act.

CAPITAL STOCK

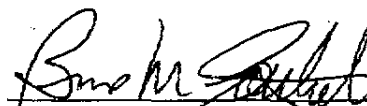
