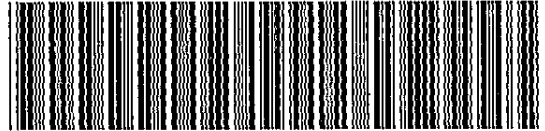

The number of directors may be increased or decreased

By-Laws, but shall never be less than one (1). The Corporation
shall indemnify and hold harmless each person who shall
