# ARTICLES OF INCORPORATION EARLY BIRD MESSENGER, INC.

The undersigned incorporator, a natural person competent to contract, does hereby make; SF subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act:

Article L. Name

The name of the corporation (the "Corporation") shall be EARLY BIRD MESSENGER, INC.

#### Article II. Principal Office and Mailing Address

The principal office and mailing address of the Corporation shall be:

#### Article III. Nature of Corporate Business and Powers

The general nature of the business to be transacted by this Corporation shall be to engage or transact in any or all lawful activities or business permitted under the laws of the United States and the State of Florida.

#### Article IV. Capital Stock

- Authorized Shares: The total number of shares of capital stock that the Corporation has the authority to issue is 110,000 shares; consisting of 100,000 shares of common stock \$.01 par value and 10,000 shares of preferred stock, \$.01 par value.
- Rights for Preferred Shares: The board of directors is expressly authorized to adopt, from time to time, a resolution, or resolutions providing shares in each such series and to fix the designations and powers, preferences and relative, participating, optional and other qualifications, limitations and restrictions of such shares, of each such series.
- Denial of Preemptive Rights: No holder of any shares of the Corporation of any class now or in the future authorized shall have any preemptive right as such holder (other than such right, if any, as the board of directors in its discretion may determine) to purchase or subscribe for any additional issues of shares of the Corporation of any class now or in the future authorized.

Article V. Registered Office and Agent

#### Article X. Initial Director

- 11.2 The Corporation may pay in advance any expenses (including attorneys= fees) that may become subject to indemnification under paragraph 11.1 above if the person receiving the advance payment of expenses undertakes in writing to repay such payment if it is ultimately determined that such person is not entitled to indemnification by the Corporation under paragraph 11.1 above.


## ARTICLE XII Affiliated Transactions
