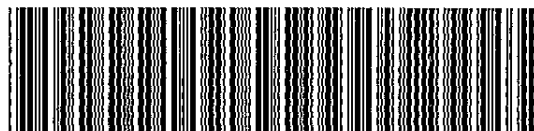



ARTICLES OF INCORPORATION

OF

CONSOLIDATED PUBLIC SAFETY SOLUTIONS OF AMERICA, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name and address of the incorporator is JOHN A. PANYKO of 200 South Tarragona Street, Pensacola, Florida 32502.

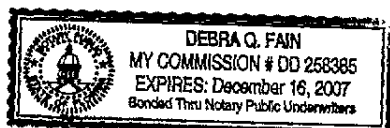
