# ARTICLES OF INCORPORATION OF MICHAEL G. COOK, D.M.D., P.A.

The undersigned, hereby associate themselves for the purpose of becoming a professional corporation for profit under the provisions of Chapter 607, FLORIDA STATUTES (2005), the "Florida General Corporation Act" and Chapter 621, FLORIDA STATUTES (2005), the "Professional Service Corporation Act" of the State of Florida, and pursuant to the following Articles of Incorporation.

### ARTICLE (

## **ARTICLE II**

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be Ten Thousand (10,000) shares of the par value of One (\$1.00) Dollar per share, all of which shall be common stock of the same class. This corporation reserves the right to amend, alter, change or repeal any provision contained herein in the manner now or hereafter prescribed by law, and all rights conferred on the stockholders herein are granted subject to this reservation.
