The undersigned subscriber to these Articles of Incorporation hereby forms the corporation under the laws of the State of Florida, as follows:

FIRST: The name of said corporation shall be KV FIVE CORP., a Florida Corporation. The mailing address and the street address of the principal office of the corporation shall be: 2999 NE 191 St. Street, PH 8 Aventura, FL 33180.

SECOND: KV FIVE CORP., a Florida Corporation, shall have a perpetual duration from the date of filing of these Articles of Incorporation.


