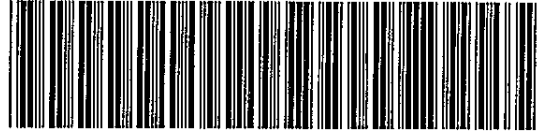

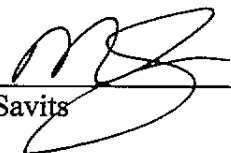

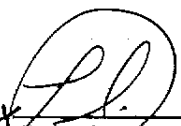
ARTICLE X: AMENDMENT

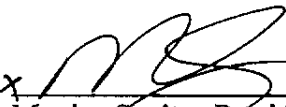
