

ARTICLES OF INCORPORATION OF:

L. & G. GARAGE DOORS, CORP. 1166 N.W. 58 Terrace Miami Florida 33127

ARTICLE I - NAME

The name of this corporation is: L. & G. GARAGE DOORS, CORP.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commerce its existence upon the signing of these Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This componation is authorized to issue 500 (FIVE HUNDRED) shares \$1.00 (ONE DOLLAR) per value.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which be already holds,

shall have the right to purchase this pro ratashare thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
