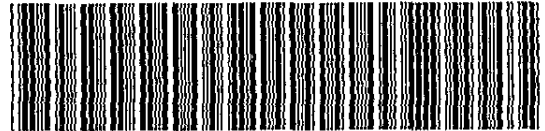

These Articles of Incorporation are made and acknowledged by the undersigned Incorporator for the purpose of creating a domestic professional corporation for profit in accordance with Chapter 621 Florida Statutes.

ARTICLE I

The corporate name of the corporation shall be ANNA MARIA MCGINTY, P.A.

ARTICLE II

EFFECTIVE DATE

01-03-06

The address of the principal office of the corporation shall be 3000 Holiday Drive #506, Fort Lauderdale, Florida 33316. The mailing address shall be the same.

ARTICLE III

The corporation is organized to engage in any lawful act or activity for which corporations may be organized under the provisions of the Florida Professional Service Corporation and Limited Liability Company Act (Chapter 621 Florida Statutes). Without limitation of the foregoing, it is anticipated that the initial business of the corporation will be real estate.

By-Laws of the corporation. Cumulative voting for Directors shall not be permitted.






