The name of this corporation is TINY TOWN EARLY LEARNING CENTER, INC.



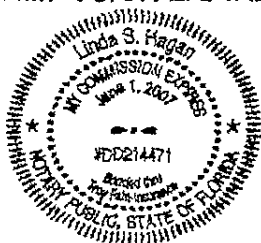
