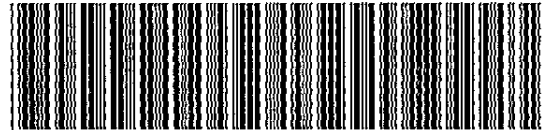

ARTICLE ONE

The name of the corporation is **INDEMAND PROPERTIES, INC.**
