

## ARTICLES OF INCORPORATION OF ALL COUNTY PERMITS, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this Corporation is ALL COUNTY PERMITS, INC.

#### ARTICLE II-PRINCIPAL OFFICE
