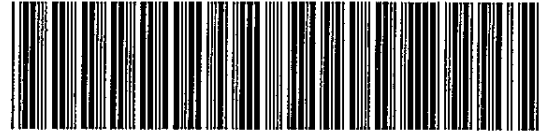



**ARTICLES OF INCORPORATION
OF
AMELIA DIAMOND CLEANING SERVICES, INC.**

In compliance with the requirements of Chapter 607 Florida Statutes [2005], the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing these Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE ONE - NAME:

The name of the corporation [herein, "Corporation"] is


