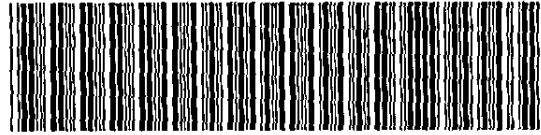

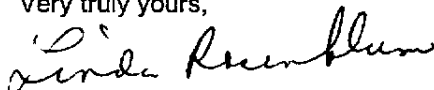

ARTICLES OF INCORPORATION
OF
LINDA ROSENBLUM, PA

- ARTICLE I.** The name of this corporation is Linda Rosenblum, PA, operating at 20247 Hacienda Ct., Boca Raton, FL 33498.
- ARTICLE II.** This corporation shall have perpetual existence, unless sooner dissolved according to law.
- ARTICLE III.** This corporation is organized for the following purpose: Real Estate.
- ARTICLE IV.** This corporation is authorized to issue One Thousand (1000) shares of common stock having a par value of \$1.00 per share.
- ARTICLE V.** The street address of the initial registered office of this corporation is: 20247 Hacienda Ct., Boca Raton, FL 33498 and the name of the initial registered agent of this corporation is Linda Rosenblum, located at 20247 Hacienda Ct., Boca Raton, FL 33498.
- ARTICLE VI.** This corporation shall have 1 Director initially. The number of directors may be increased or diminished from time to time by By-Laws, but shall never be less than one. 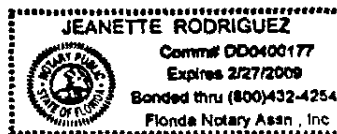
