Dear Mr. Toner:

As the accountant for the above referenced corporation, I was requested to respond to your notice (a copy of which is attached) dated June 14, 2007 in which you are requesting a payment in the amount of \$400 as a late filing fee.

I spoke with you earlier today in reference to this notice. I prepared the Uniform Business Report on April 10, 2007 and mailed it to my client for his signature and payment of the fee. I sent it by U.S. Mail. The client received the package on June 9th. He signed it, dated it and prepared a check for the \$150 fee the date I prepared the return (April 10th). He then mailed it to your office on June 12th. Subsequently he received the late filing notice. I was completely unaware that it took two months for the package to arrive at my client's home. Had I known of the problem, I would have either had the taxpayer pick up the form from me, faxed it to him or electronically filed online.

Based upon the above, I respectfully request that the penalty be abated since we were unaware of the delay by the U.S. Mail as well as it was unreasonable to suspect such a delay.
