The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: ROA GONZALEZ CORPORATION. The principal office of the Corporation is 1403 La Paloma Circle, Winter Springs, Florida 32708. The mailing address of the Corporation is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.
