The undersigned incorporator, BRADLEY VROON, an individual authorized to contract, hereby presents these Articles of Incorporation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - Name

The name of this corporation is BD Vroon, Inc.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 570 Woodland Bayou Drive, Santa Rosa Beach, Florida 32459.

ARTICLE III - PURPOSE

This corporation organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK
