# ARTICLES OF INCORPORATION DECRETARY OF STATE OF TALLAHASSEE, FLORIDA FUH-GET ABOUT IT FENCING, INC.

The undersigned incorporator, for the purpose of forming a corporation under Section 607 of the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is FUH-GET ABOUT IT FENCING, INC. (hereinafter called the "Corporation").
