The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name and Principal Office

The name of this corporation shall be: OWLMOVEMENT.COM, INC. The principal office of this corporation shall be: 3 Lake Hollingsworth Drive, Lakeland, Florida 33803.

ARTICLE II

Business and Purposes

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE III

Capital Stock

- (a) The aggregate number of shares of capital stock authorized to be issued by the corporation shall be 7,500 shares of common stock with a par value of \$.01 per share. Existence of Corporation

This corporation shall have perpetual existence.

Registered Office and Registered Agent

Board of Directors

The stockholders of this corporation may remove any director from office at any time with or without cause.
